What specific qualifications or prerequisites are needed for participants before enrolling in the course?

How long is each day's session, and is there a total number of hours required for the entire course?

How is this course different from general finance training programs?

This program is structured around the real responsibilities of a Financial and Investment Analyst. Instead of covering finance broadly, it focuses on measurable outputs such as valuation models, portfolio risk analysis, capital budgeting decisions, and executive investment reporting.
